

ISSUES

INCREASING THE RECREATIONAL FACILITIES LIMIT

Recreational facilities in Municipal Utility Districts (MUDs) and other water districts play an important role in communities. Currently, only 1% of the taxable value of property in these districts may be used to support bonds that pay for recreation facilities. Recreational facilities provide many health benefits to residents in MUDs and other water districts.


BUFFALO BAYOU

The Army Corps of Engineers released plans to reduce flooding in the Houston area. The key is to find a way to convey additional flood waters from the reservoirs to Galveston Bay. The plan involved creating a new reservoir on the Katy Prairie and bayou channelization. The plan was met with resistance because it would decimate the biodiversity and reshape one of the Houston's greatest urban treasures.

The West Houston Association participated and helped with the coordinated effort to respond to the Army Corp of Engineers report of the Buffalo Bayou.

87TH LEGISLATIVE AGENDA

Our 87th Legislative Agenda was completed in October and it included topics concerning increasing the recreational facilities, funding for transportation, support for sustainable infrastructure and flood control.

ISSUES

MASTER PARKS PLAN

The WHA Parks, Recreatiom, and Open Spaces committee announced that it would begin working on a Master Parks Plan in November. This document will serve as a comprehensive framework for the classification, usage, size, and facility recommendations for parks and greenspaces in the Greater West Houston area.

ENVISION CREDENTIALING

The West Houston Association hosted two Envision Credentialing Course on May 7th and October 14th to prepare professionals for the Sustainable Infrastructure Credentialing Test. The 8-hour course was held in a virtual format for the first time. Instructors Michael Bloom, Sustainability Practice Manager at R.G. Miller, and Liz Parent, a Principal Engineer at 5engineering, LLC taught the class. Of the 3 Envision courses held by the West Houston Association, over 60 attendees now have the ENV-SP credential.

The Envision credential increases personal marketability for professionals, provides a valuable return on investment for organizations that deliver infrastructure project, and is becoming a globally recognized credential in civil engineering.

MEMBER OP-ED ARTICLES

Developers, MUD's, and Architects are Creating More Green Space in Houston - Deborah January-Bevers

As a follow up piece from the Blues to Greens Forum and promotion of the MPC Ecoregions Experiences Event Program (MPCE3), Deborah January-Bevers wrote an op-ed on how and why green space is important in urban and residential open spaces. The article also featured information concerning the 8-county Gulf-Houston Regional Conservation Plan (RCP) and how Houston Wilderness keeps track of the amount protected/preserved green space in each of the 8 counties.

FORUMS

DEVELOPING SUSTAINABLY: GREEN DEVELOPMENT

The Green Development Forum was held at the Embassy Suites on February 6, 2020 to discuss policies concerning sustainability with representatives from the private and public sectors. Panelists included Patti Joiner, John Blount, and Peter Barnhart. Natalie Chaney, Team Lead at RPS, was the moderator.

TRI-COUNTY JUDGES FORUM

The West Houston Association's Tri-County Judges Forum was held virtually on June 11, 2020 featuring a panel of local county judges – Judge Duhon of Waller County, Judge Hidalgo of Harris County, and Judge George of Fort Bend County. Each judge provided updates on county initiatives and their collaborative efforts on issues pertinent to the region, including mobility, infrastructure, flooding, and COVID-19. Heath Melton, Executive Vice President, MPC at Howard Hughes Corporation and Board Chairman of the West Houston Association, moderated the panel with questions from attendees.

BLUES TO GREENS

The West Houston Association held a virtual forum on July 23, 2020 to discuss the interplay between water conservation (blue) and optimizing open spaces (green). A panel of conservation and recreation professionals discussed master-planned spaces and their impact on the region. This event was moderated by Alia Vinson, Partner at Allen Boone Humphries Robinson LLP and Vice-Chair of the WHA Water Resources Committee. Panelists included: Tricia Brasseaux, Rob Bamford, Matt Baumgarten, and Deborah January-Bevers.

FORUMS

CITY ISSUES FORUM

The WHA City Issues Forum took place on May 14, 2020 in a virtual format, featuring Mayor Sylvester Turner. Over 130 participants attended the virtual event. The mayor's remarks focused on the \$169 million budget shortfall for the next fiscal year and infrastructure in Greater West Houston.

FLOOD CONTROL

The West Houston Association held a virtual forum on August 4th, 2020 to discuss ongoing efforts to improve flood control infrastructure. Moderator and WHA Flood Control Committee Chair, Tim Buscha, President of IDS Engineering Group, noted the importance of keeping the constituency educated on causes of flooding and how to be strong advocates for continued funding.

Russell "Russ" Poppe, Executive Director for the Harris County Flood Control District stressed the importance of flood insurance, provided updates on projects and funding, and mentioned that the Harris County Flood Control Task Force is being repurposed into a Community Resiliency Task Force to suit the county's needs. Kathleen Jackson, Director on the Texas Water Development Board, spoke about state level initiatives and funding opportunities.

STATE ISSUES FORUM

Over 90 members and guests of the West Houston Association attended an update on the state of the Texas economy during a virtual forum on September 30th. Texas Comptroller Glenn Hegar participated in a wide-ranging discussion moderated by Howard Cohen, Partner at Schwartz, Page & Harding LLP. Hegar discussed the budget surplus forecast and how it turned to a multi-billion dollar deficit.

Hegar also discussed the upcoming 2021 budgeting session, improving the Houston-area flood infrastructure in the post-Harvey era, and the significance of rebuilding consumer confidence as it relates to the state's economic recovery.

FEDERAL ISSUES FORUM

The WHA Federal Issues Forum featuring U.S. Representative Dan Crenshaw (TX-2) took place virtually on October 29th. In a wide-ranging questionand-answer session moderated by long-serving Fort Bend County Judge Bob Herbert, Crenshaw spoke about energy, infrastructure, education, and of course, the Covid pandemic.

VIRTUAL HAPPY HOUR AND PUB QUIZZES

2020 was the year of the virtual connection. We hosted 3 virtual happy hours and released a color changing signature drink, the WHA Quarantini. The happy hours gave **Rising Leaders** the opportunity to introduce themselves to their mentors, to welcome staff members, and to honor our outgoing president for his 4 years of service at the West Houston Association.

CONNECTING DESPITE COVID-19

QPD PROPERTY TOURS

WHA members taking part in the Rising Leaders program participated in two different tours last year at Towne Lake and Bridgeland to learn more about the Quality Planned Development (QPD) program and the criteria to become a QPD recognized site.The first tour took place on September 11th at Towne Lake, in Cypress, Texas. Towne Lake, a Caldwell Company property, was recognized as a Quality Planned Development in 2013. This year, it has been recognized as a Houston Business Journal Landmark award-winning community.

The second tour took place on September 24th at Bridgeland, in Cypress, Texas. Bridgeland, a Howard Hughes Corporation property, received Quality Planned Development (QPD) recognition in 2012, and in 2019 was recognized as a Houston Business Journal Landmark award-winning community. Attendees met at Dragonfly Park in the Emerald Room where Lona Shipp, a member of the fourth Rising Leader cohort and Director of Residential Marketing for Bridgeland, gave a presentation on how Bridgeland qualified for QPD recognition by setting superior standards in the way they designed this master planned community.

MPC ECOREGIONS EXPERIENCES EVENT PROGRAM

Houston Wilderness and Cross Creek Ranch, along with the West Houston Association held a virtual session on October 22nd that highlighted the importance of using recreational facility bonds to support the development of projects that provide environmental and flood resiliency benefits in masterplan communities, and other municipal utility districts. The first MPC E3 event took place on February 27, 2020.

RISING LEADERS ENGINEERING LABOR MARKET PANEL DISCUSSION

During a panel discussion hosted by the West Houston Association's Education and Workforce Development Committee on August 12th, 2020, our Rising Leaders learned about the progress being made in a key component of the West Houston 2060 Plan. Panelists covered the current state of educational opportunities and workforce needs that the the UH/HCC Engineering Academy at Katy is poised to help shape, as well as forecasted labor force demands in the future.

RICE STUDENTS AND WEST HOUSTON

WHA worked with students from Rice University to identify ways to improve West Houston's "Cool Factor", an expression to represent the area's arts, culture, dining, entertainment and social scene.

STAR OF EXCELLENCE

The WHA Star of Excellence award is given to one person each year for outstanding contributions to West Houston.



COMPASS AWARDS

Michael Bloom, Sustainability Trailblazer, was given a WHA Compass Award for his remarkable efforts in aiding WHA's promotion of the Envision Rating System, a best practice guide on developing and implementing resilient and sustainable infrastructure.

Bill Callegari and Todd Burrer for their

extraordinary efforts in seeking a resolution to the growing decline in regional water service operators though the development of the Water Workforce Initiative.

AWARDS

STAR OF EXCELLENCE

Steve Radack was given the award for three decades of service to continuously improve the quality of life for people across West Houston in Precinct 3 and beyond.

SUSTAINABILITY STARS AWARDS

The Sustainability Stars program awards applicants for projects focusing on land development and infrastructure in the Greater West Houston area. Applicants are assessed on five areas: investigation, investment, integration, inspiration, and innovation; projects can receive up to five stars for meeting requirements in each area. Three projects were honored with Sustainability Stars this year.

Jim Russ, President of EHRA Engineering and WHA Sustainable Infrastructure Committee Chair, announced this year's winning projects: **Towne Lake Water Re-Use**, **Cinco MUD 1's De-salination Water Plant, and Cinco MUD 1's Waste-Water Treatment Plant Water Re-use**.

QUALITY PLANNED DEVELOPMENT DESIGNATION

WHA held its annual award ceremony on Tuesday, December 1 st to celebrate the work of the membership during a uniquely challenging year. Two developments were recognized as Quality Planned Developments (QPD): **Grayson Woods in Katy and The Woodland Hills in Conroe**, bringing the total to 24 recognized developments in the Greater Houston region.

In announcing this year's recipients, Rob Bamford, WHA Quality Planned Development Committee Chair, said that the award certifies that the developers have invested considerable thought and effort in creating amenities and value for their residents.



We created a new 2020 Development Map. This year's version now includes Sustainability Star winners and two Map App instructional videos, created by BGE Inc.

2020 MEMBERSHIP HANDBOOK


2020 DEVELOPMENT MAP
